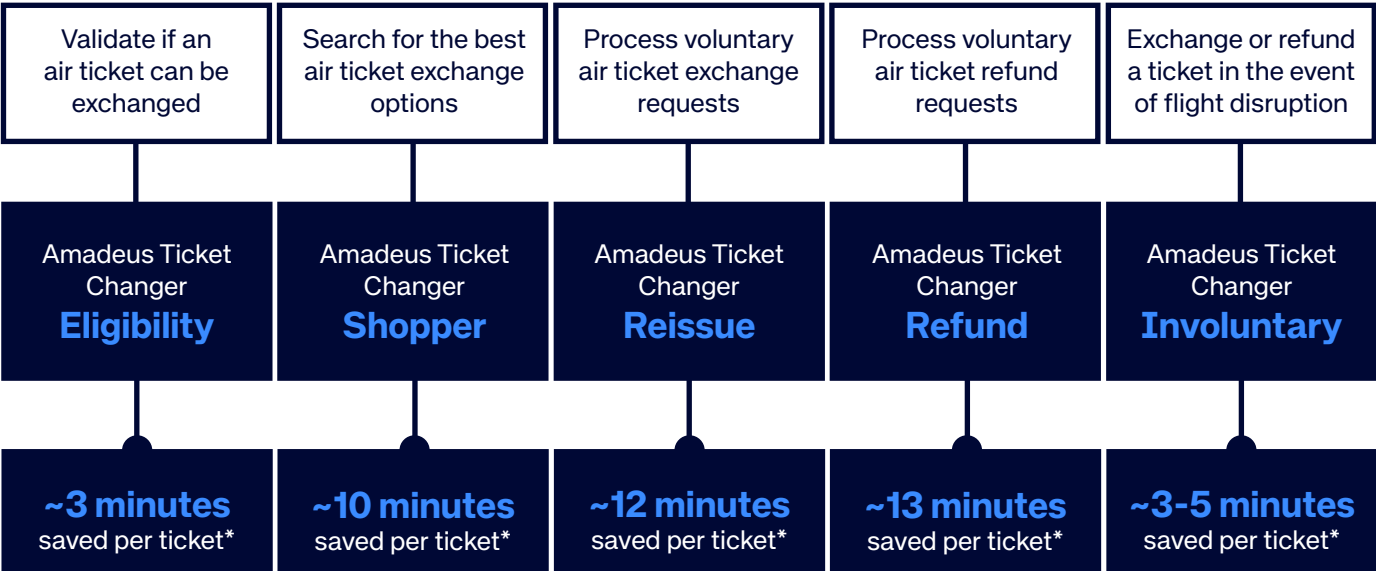

Amadeus Ticket Changer Eligibility

Amadeus Ticket Changer Eligibility empowers travelers to check the exchange fare rules applicable to their flight tickets and automatically returns any applicable restrictions and penalties.

The product verifies and confirms whether an air ticket is eligible for exchange, checked against ATPCo Category 31 fare rules filed by the airlines. The tool automatically retrieves the type of change that is allowed for the air ticket, determines if any penalty applies, and provides the list of airlines authorized for repricing.

Amadeus Ticket Changer Shopper empowers travelers to search for alternative flight options, returning relevant recommendations according to the conditions of their original tickets.

The product searches and displays alternative and relevant recommendations to travelers' air tickets, checked against ATPCo Category 31 fare rules filed by the airlines, and automatically computes the fare difference, taxes balance, and penalty amount. The output is available both in calendar view - displays recommendations for a given range of dates (up to + / - 3 days) - and in TravelBoard view - displays up to 200 recommendations for a chosen date.

Any changes are processed: date, time, origin, destination, and more.

Amadeus Ticket Changer Reissue

Amadeus Ticket Changer Reissue automates the ticket exchange process in the event of voluntary changes requested by travelers.

The product computes the fare difference, taxes balance, and penalty amount based on ATPCo Category 31 fare rules filed by airlines. First, the tool automatically prepares PNRs (Passenger Name Records) for reissuance or revalidation when possible, by creating the necessary documents for the new ticket (TST and TSM), storing calculation details in reissue panel (TQR), and updating the form of payment and other mandatory elements to reissue the PNR.

Amadeus Ticket Changer Refund

Amadeus Ticket Changer Refund automates the ticket refund process in the event of voluntary changes requested by travelers.

The product computes refund balance, considering the fare and the taxes to be refunded, and the penalty amount based on ATPCo Category 33 fare rules filed by the airlines. Upon confirmation of the refund transaction by consultants, the ticket status is automatically updated to “refunded”, and a corresponding reporting record is generated.

Amadeus Ticket Changer Involuntary

Amadeus Ticket Changer Involuntary product offers two modules that empower travel sellers to automate both the ticket exchange and the ticket refund processes in the event of flight disruption. Travel sellers are required to have a prior agreement with the airlines to handle these activities on their behalf.

Amadeus Ticket Changer Involuntary Reissue automates the ticket exchange process in the event of planned schedule changes by airlines. Travel agents need to retrieve updated PNRs from the corresponding input queue, containing the new itinerary details filed by airlines such as changes in arrival or departure airport or flight number. Then, the product prepares the impacted tickets for reissuance by updating the TST with the necessary elements and indicators.

Amadeus Ticket Changer Involuntary Refund automates the ticket refund process in the event of flight disruption. Travel agents need to retrieve impacted PNRs from the corresponding input queue, containing cancelled portions or segments. Then, the product waives penalty fees and calculates the refund amounts for all impacted tickets. Upon confirmation of the refund transaction by consultants, the ticket status is automatically updated to “refunded”, and a corresponding reporting record is generated.
